1. Complete the attached Nomination Form
2. Attach three signed letters of nomination detailing why you feel your school deserves to receive the IE Award. Reflect on inclusion in either your school as a whole or on the actions of specific people within the school that has made it a diverse and welcoming place to learn.

Each letter should be a minimum of one to a maximum of two typed pages.

Each school is also encouraged to submit supporting photographic documentation, with pertinent captions, to bring the total submission to a maximum of 8 pages.

Nomination Letters should come from **three** of the following:
